Dear Neighbours,

Welcome to the September 2020 issue of the Hallsville Quarter Phase 3 development newsletter, looking at the latest progress achieved and upcoming milestones.

#### Works progress

- We have installed our first tower crane along Silvertown Way
- We are installing the new hoarding and refreshing the existing hoarding where needed
- We have started the concrete piles works to the basement early August on blocks E&F
- The concrete pile caps and foundations works of block D2 on Silvertown Way are progressing
- Essential car park works to connect the Morrison and HQ1 basement car park to the new vehicle access ramp to/from Silvertown Way surface car park will take place on the evening of Sunday 6<sup>th</sup> September. In addition we shall open a new pedestrian walkway from Silvertown Way to Silvertown Square, which replaces the existing pedestrian walkway from the surface car park. We are sorry for the inconvenience but this operation must be carried out when Morrisons is closed and the traffic in the car park is minimum, for safety and logistic reasons.
- We will start the installation of underground services works during the month of September.
- At the end of August, we will start the remaining of the excavation on Morrison's Car Park.

In agreement with the London Borough of Newham Council, the construction working hours have changed to 7:30am to 7pm, Monday to Friday and 8am to 1pm on Saturday.

#### **Events – Ground Breaking Ceremony**

On Monday 10th August, the Hallsville Quarter Phase 3 team welcomed the Mayor of Newham and our partners Grainger plc and One Housing Group onto our Hallsville Quarter site for a ground-breaking ceremony to celebrate the start of work on phase three of this significant regeneration project.
