Dear Neighbours,

Welcome to the December 2020 issue of the Hallsville Quarter Phase 3 development newsletter, looking at the latest progress achieved and upcoming milestones.

## Works progress

We shall be installing additional tower cranes over two weekends in December, from 08:00am to 18:00pm, minimising health and safety risks and impact on highways traffic around the site. There will be large delivery trucks and mobile cranes travelling to/from the site during the installation.

The noise level should remain very low and we will minimize activities during the early morning.

- ⇒ TC1 (block E) erection on 5<sup>th</sup> & 6<sup>th</sup> December 2020
- ⇒ TC2 (block E&D1) erection on 12<sup>th</sup> & 13<sup>th</sup> December 2020
- ⇒ In the event of adverse weather conditions, we might need to postpone one of the installations until the weekend of the 19<sup>th</sup> & 20<sup>th</sup> December 2020.


The main construction works has progressed as follows:

- ) Foundations in blocks E and F: (piles caps and ground beams) are progressing well
- ) Block F: Structural slab and walls at basement level have started
- ) Block D2: first-floor slab & walls are progressing well
- ) Below ground services have started
- ) The hoarding branding was installed and includes photographs and artwork designed and photographed by the local community in collaboration with Newham Council

The site installation drawing above right shows the location of each of the blocks mentioned.

## Events

We have partnered up with Solutions for the Planet and will be participating in a STEM challenge with one of the local schools (Stratford Academy). This will be launched in December and runs until April 2021. We will share more details with you after the launch. We are also working with the local DWP providing some workshops and in 2021 hosting some work experience opportunities.
