Works progress

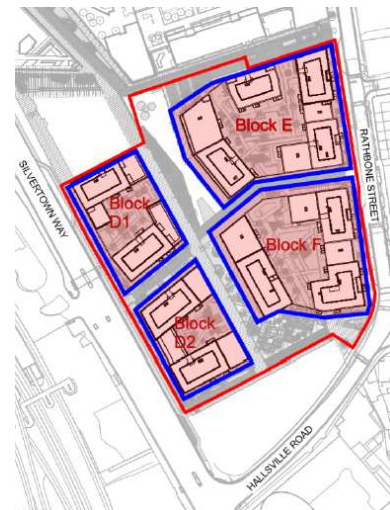
- Our structural concrete works reached Level 3 on Block D2 and continues to progress.
- The foundations were completed for Blocks E and F and we are now progressing with the walls and slabs of the podium levels. We will start Level 1 concrete slab in early April 2021.
- The external drainage works continue to progress mainly on the eastern part of Blocks E and F, along Rathbone Street.

Events

The team continue to work with Newham Workplace on job opportunities and work experience placements. We are also working with the Department of Work and Pension in Newham and the Job Centre Plus in Canning Town.

Last month, Bouygues UK Project Team presented the project to two major primary school in the borough, Scott Wilkie and Hallsville Primary. As part of this presentation we showed the students time lapse and drone footage of the site.
