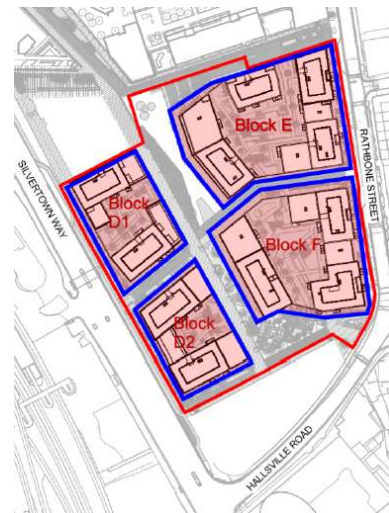

Welcome to the May 2021 issue of the Hallsville Quarter Phase 3 development newsletter, which reviews the latest progress achieved on site and the upcoming milestones.

Works progress

- Our structural concrete works reached Level 4 on Block D2 and continues to progress.
- Block E is progressing well on the ground floor. We will shortly start the works on the first floor.
- The foundation work to the duplexes on Rathbone Street will begin this month.
- Block F continues to progress on the first floor which will include both retail and residential units,
- The external drainage works continue to progress mainly on the eastern part of Blocks E and F, along Rathbone Street.

The team continue to work with our Newham work on job opportunities and work experience placements including Department of Work and Pension in Newham and the Job Centre Plus in Canning Town.

We will organise site visits and workshops for the University of East London (UEL) and London Design & Engineer (UTC) college in coming months in compliance with government guidelines.
