Welcome to the September issue of the Hallsville Quarter Phase 3 development newsletter to update you on the latest progress achieved on site and any upcoming milestones.



Progress to Date

Building D2

Internal trades sequence in flats is on-going from level 01 to level 13, works ongoing include 2nd fix joinery complete up to level 05 with level 06 currently in progress, live testing has commenced to levels 03 and 04, snag in progress.

Utility cupboard remedial works completed with all sections of pipe susceptible to galvanic corrosion replaced.

Level 01 - 03 apartments in progress and to be completed by end of the month.

A staircase mist coat has been completed with electrical containment commenced.

Blockwork to the ground floor remains in progress with the areas required for early access to the client starting first and prioritised, remaining areas of blockwork have also started.

Building E & F

Scaffold erection has been completed, all except Block E1. Window installation is ongoing in Block E1 balconies east elevation. Brickwork works are progressing on Block F2. Roofing screen posts installation is ongoing on block E and F roofs. Curtain wall Block F level 01 and ground floor is ongoing. The residential fit-out is progressing well.

Building D1:

Piling has now commenced.

Forthcoming Construction

Building D2

Internal fit-out sequence: final decs to commence, carpet, ME finals.

Facades: continuation of the external façade works including ground floor brickwork, SFS, and curtain walling.

Building E & F

Complete main scaffold. Complete the installation of all windows. Brickwork to start concrete banding in E3 and E1. Complete roofing and all waterproofing on balconies. Benchmark flats inspection and snagging.

Building D1:

Piling and Pile caps works ongoing.
